

# Dear Friends,

This year we are celebrating 35 years of putting love into action! Since 1984 Amate House has partnered with more than 200 social service agencies, schools, and pastoral ministries across Chicago to serve those most in need. Amate House fellows have worked as teachers, nurses, case managers, and youth leaders. This past year has been no exception!

Amate House fellow, Davis Brown, taught science and math at the Academy of St Benedict the African for 200 students living in Englewood, one of Chicago's most violent neighborhoods. He has continued on at the school teaching full-time after his volunteer year. Megan Clarke provided food for over 2,000 people in her work at the St. James Food Pantry. Today she's living in Indianapolis hoping to secure a position in nonprofit development. Brian O'Connor taught young students about healthy lifestyles in a community where access to medical services is limited. He's currently attending medical school at the University of Cincinnati. These are just a few ways Amate House fellows made a difference in the lives of Chicago's most vulnerable residents in 2018 and how they continue to do so after their service year.

Many exciting things happened at Amate House in 2018. We launched a new website and re-branded our program to better reflect the breadth and depth of programming and the expectations we have for our young adult participants. Amate House is more than just a year of volunteer service; it is a fellowship experience complete with training, education, and real world learning opportunities as well as full-time service and community living. Volunteers are now referred to as fellows and the year of service is now called a year of social justice leadership development.

We also doubled the number of participants we recruited for our current cycle to eleven fellows and added three new service sites: Arrupe College, Domestic Violence Legal Clinic, and Envision Unlimited. We're confident that we will continue to increase the number of young adults participating in our leadership development programming. Our goal is to also recruit a more diverse group of fellows which, we believe, will enhance the group's program experience. We also hope to add service sites that work on behalf of environmental justice and community development.

Your support over the years has allowed Amate House fellows to have an enormous impact on Chicago. To date, they have donated over 1.4 million service hours valued at over \$34 million to the city's most vulnerable communities. And they continue to live out the Amate House tenets of service, social justice faith, stewardship, and community wherever they go after their year of leadership development training.

We are humbled by our 35 years of service and plan to continue to serve Chicago for another 35 years and beyond! We look forward to all of the wonderful things that will happen this year and to sharing that success with you. Thank you for all you do on behalf of Amate House. We are grateful to have you as a partner in our quest to put love into action in Chicago.



## Revenues, Gains and Other Support




